Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders representatives who choose to attend at 22-06-2018 12:30 hours at the office of Rastriya Banijya Bank Ltd. Central Office, General Service Department, Singhdurbarplaza, Kathmandu, Nepal
6. Bids must be valid for a period of 90 of days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 4,74,120.00 (Four Hundred Seventy Four Thousand One Hundred Twenty Only)** which shall be valid for 30 days beyond the validity period of the bid.
